This is in continuation to the Exchange Circular no. NCDEX/TRADING-055/2023 dated December 11, 2023 and Circular no. NCDEX/TRADING -015/2024 dated April 29, 2024 captioned on Format of Report downloads – Exchange (UDiFF) regarding the file formats for Exchange Trade and Bhavcopy file with regards to Standardization of Exchange to Member Interface files in Unified Distilled File Formats.

Based on feedback received from Back-office Vendors and Members, following revisions will be done in the UDiFF catalogue and files being downloaded with effect from **Monday**, **June 10**, **2024**. The details of revisions made are given below:
