Subject : Investor Grievance Redressal Mechanism

This is with reference to Exchange circular no. NCDEX/INVESTOR SERVICES-002/2023 dated March 31, 2023 pertaining to Arbitration Mechanism at Exchange and circular no. NCDEX/Investor Services-002/2016/166 dated July 19, 2016 on Investor Grievance Redressal System and Arbitration Mechanism.

SEBI vide circular SEBI/HO/OIAE/OIAE_IAD-3/P/CIR/2023/195 dated August 04, 2023 has introduced Online Dispute Mechanism which harnesses online conciliation and online arbitration for resolution of disputes arising in the Indian Securities Market.

Further, the Exchange, vide circular no. NCDEX/INVESTOR SERVICES-001/2023 dated January 12, 2023 had introduced Online Web based Complaint Redressal System called NEST to facilitate clients and members in filing their complaints, Arbitration on Exchange Platform.

In view of the above, Member and their constituents may file their complaints and register online conciliation and online arbitration for resolution of disputes/complaints on the following portals.
