In this context, Clearing Members are hereby informed, that the Volatility Scan Range (VSR) for Options contracts in commodity derivatives segment has been reviewed for the month of June 2023. The VSR has been revised for Maize - Feed/Industrial Grade. There is no change in VSR for the remaining commodities. The VSR shall be as follows:

Turmeric	TMCFGRNZM	8%
