This is with reference to SEBI circular No. SEBI/HO/CDMRD/DRMP/CIR/P/2021/08 dated January 11, 2021 and NCCL circular no NCCL/RISK-043/2022 dated November 11, 2022 on Review of Volatility Scan Range (VSR) for Option contracts in Commodity Derivatives Segment.

In this context, Clearing Members are hereby informed, that the Volatility Scan Range (VSR) for Options contracts in commodity derivatives segment has been reviewed for the month of January 2023. The VSR has been revised for Maize - Feed/Industrial Grade from 11% to 10% and for Guar Seed from 7% to 8%. There is no change in VSR for the remaining commodities. The VSR shall be as follows:

Guar Gum Refined Splits	GUARGUM5	8%
Guar Seed	GUARSEED10	8%
Jeera	JEERAUNJHA	8%
Maize - Feed/Industrial Grade	MAIZE	10%
Turmeric	TMCFGRNZM	8%
